What are Lateral Flow Tests

Earlier this year, the UK Government announced they would be expanding the offer of asymptomatic (people without any symptoms of Covid-19) testing to critical workers who cannot work from home during this period of national lockdown restrictions.

Lateral flow tests (LFTs), also known as lateral flow devices (LFDs), are rapid tests which are used for asymptomatic testing to identify cases of Covid-19. With 1 in 3 people with coronavirus never showing any symptoms but still being infectious, LFTs can identify cases which would have gone unidentified and avoid spreading the virus to others.

Local authorities have opened up Lateral Flow Test sites for targeted groups who cannot work from home and it is to these sites that there is opportunity for members of the community who are engaged in activity with their communities to attend for a test.

Access to LFT's

Small businesses and organisations in both the public and private sector with less than 50 staff, sole traders and self-employed citizens can access asymptomatic testing through community testing sites provided by the local authority in your area.

To have access to the community testing:

- You will need to provide details of the number of staff in the organisation, which will need be to less than 250 staff
- · Employees include those who do not have access to LFT already
- · Employees have to be identified as critical workers (including essential voluntary work)
- · You will be provided with booking information
- Employees will then be able to access the test twice a week, minimal once a week Community testing will be provided for businesses that are unable to access testing provided through other channels.

Community Testing

Testing is being made available to those people who are permitted to leave home for work (including essential voluntary work) and who are unable to access asymptomatic testing through other routes, particularly those who are critical to supporting communities, responding to the pandemic and/or at higher risk of infection and transmission

Organisations that can access community testing include:

- · Small or local public sector organisations
- · Charities and voluntary groups
- · Small or local private sector businesses providing key public services and unable to access institutional testing; e.g. waste management, public transport, taxi firms, power and water companies etc.
- Education or childcare settings not covered by existing schools testing; e.g. private nurseries, children homes, childminders etc.
- · Medium sized local businesses (generally businesses between 50 and 250 staff) unable to practically access institutional testing
- · Small or local businesses (generally less than 50 staff), and including sole traders or self-employed citizens
